8. Director's Report: All members of the 9-1-1 board received a copy of the Director's Report.

- Sheriff Goodnough asked Director Kuti to look at the time a call comes into dispatch to when it is dispatched out. He acknowledged there are a lot of variables that can effect that number.
 - Director Tolstedt asked Director Kuti if she knew of any other agencies that measure this.
 - Director Kuti stated she doesn't know of any other agencies that get that finite with their reports. She explained there are a lot of outlying variables that will affect the final numbers.
 - General discussion about comparing our numbers to comparable agencies.

Mr. Williams made a motion to accept the Director's Report as presented; supported by Dr. Kemple with the correction of the date on top of the report. **Motion carried.**

9. Citizen's Time: None.

10. Member's Time:

- Director Tolstedt stated there were new protocols signed. He asked Dr. Kemple to address that.
- Dr. Kemple stated he sent out the protocols for awareness. He stated that when an ambulance has been dispatched, only an EMS unit can cancel them with very little exceptions. He stated that unless there truly is no patient, we don't cancel EMS.
 - Director Tolstedt asked after law enforcement arrives on scene, can the response priority be reduced.
 - Director Kuti explained that when first responders get on scene and update dispatch with information, we update fire and ems. It is up to them to make a decision to change their response.
 - General discussion
- Commissioner Hoffman commented how interesting it is to listen to the teamwork. He stated this group takes good care of the citizens of Monroe County.
- Prosecutor Yorkey stated mental health concerns are a bigger issue and they are absent at this table.
 - General discussion about mental health crisis unit.
 - Director Kuti stated if we get to a point where we use the mental health protocol within dispatch, she has no objection to having the crisis team out for a presentation.
- Dr. Kemple stated EMS week just passed. He thanked all of our EMS providers.
- Director Kuti stated she will have a small presentation at the next meeting for retired Supervisor Crissy Miller. She wasn't able to make the meeting due to serving jury duty.
